1. Who this agreement is between

This agreement is between Soham Kochikar trading as Voyager Academy Australia, ABN 18 633 079 376 ("Voyager Academy", "we", "us", "our") and the student named in the acceptance block at the end of this document, together with the parent or guardian who signs it ("you", "the student").

If the student is under 18, the parent or guardian signs this agreement, accepts it on the student's behalf, and is responsible for paying the fees.

This agreement covers our interview preparation programs, any additional lessons or mock interviews you book, and your access to the Interview Question Bank. It sits alongside our terms and conditions and our privacy policy, both at voyageracademy.com.au. Where this agreement and the general terms differ on the interview programs, this agreement applies.

2. What you are enrolling in

We run two interview preparation programs. Both follow the same curriculum.

1-on-1 Program \$805.50	Small Group Program \$625.50
• 5 one-on-one lessons covering the full curriculum • 1 full-length, university-specific mock interview with a written feedback report • Access to the Interview Question Bank	• 5 group lessons covering the full curriculum, in a class of 2 to 3 students • 1 full-length, university-specific mock interview, sat individually, with a written feedback report • Access to the Interview Question Bank

Lessons run for one hour unless we tell you otherwise before the lesson, and are delivered online over video call. We schedule each lesson with you by agreement, around your availability and ours.

For group lessons, we prefer students to bring their own pair or trio, because this avoids delays in getting classes started. If you cannot find your own group, we recommend enrolling in the 1-on-1 Program instead. You are welcome to wait while we look for a suitable student to pair you with, meaning someone preparing for the same universities as you, but we cannot guarantee that we will find one, or how long it will take.

Your enrolment is personal to the student named at the end of this agreement. It cannot be transferred to another student, including a sibling or other family member.

3. Fees and how payment works

Continuing UCAT student rates. Every fee in this agreement is 10% below our standard rates. The discount is for students who are currently enrolled in, or have completed, a Voyager Academy UCAT program. All amounts shown throughout this agreement already include it, so nothing further is deducted at checkout.

3.1 The starting payment

A starting payment is due before your first lesson, and secures your place. It is \$72 for the 1-on-1 Program and \$45 for the Small Group Program. Your first lesson is not confirmed until it is paid. The starting payment counts towards the program fee. It is not an additional charge.

The first lesson is a discounted lesson, not a free trial. It covers a full part of the curriculum and has value in its own right, so the starting payment is not refunded once that lesson has been delivered.

3.2 Deciding after the first lesson

After the first lesson you choose whether to continue.

If you withdraw, you owe nothing further and the balance of the program fee is not charged. Tell us by email before we book any further classes. The starting payment you have already made is not refunded, for the reason given in clause 3.1.

If you continue, we book the remaining classes and your mock interview, and the balance of the program fee becomes payable:

The balance must be paid in full before your second lesson, unless we agree another arrangement with you in writing.

3.3 Question Bank access

Access to the Interview Question Bank is granted within 24 hours of the balance of the program fee being paid in full. Access is personal to the enrolled student. It cannot be transferred to anyone else, and it cannot be shared with anyone else, including a sibling, parent or other family member.

3.4 Lesson materials and feedback

We provide the lesson slides and written feedback after each lesson. Your mock interview is followed by a written feedback report.

3.5 Additional lessons and mocks

Once you are enrolled, you can book additional sessions at these rates:

Additional group lesson	\$49.50 per hour
Additional mock interview	\$202.50

These rates apply to students enrolled in a program. Everyone else pays the standalone prices listed on our website.

3.6 Payment before the lesson

Payment for any lesson or mock interview must reach us before that lesson starts. If it has not, the lesson is treated as cancelled and the time is released to other students. This applies to program lessons and to additional sessions.

If there is a problem with an invoice, contact us before the session date so we can fix it.

3.7 GST

Fees are in Australian dollars. Where GST is payable, the fees in this agreement include GST. This applies if Voyager Academy Australia becomes required to register for GST while this agreement is on foot: the price you pay does not change, and we do not add GST on top of the fees quoted here.

4. Cancelling, rescheduling and missed lessons

If you need to move a lesson, tell us as early as you can and we will find another time.

Cancellations made more than 3 hours before the start time are free of charge.

If you cancel within 3 hours of the start time, or do not attend a booked session, the first instance carries a warning, with any future instances carrying a \$50 fee. We count these across your enrolment in the program.

An instance is not counted where there is a genuine extenuating circumstance, such as illness, a family emergency, or another serious unexpected event. We decide this reasonably and in good faith. Tell us what happened and we will take it into account.

If you are late, the lesson still finishes at its scheduled end time so that other students' bookings are not affected.

If we need to cancel or move a session, we will give you as much notice as we can and offer an alternative time. If we cancel a session you have paid for and cannot reschedule it, you receive a full refund or a credit for that session, whichever you prefer.

5. Refunds

We refund lessons and mock interviews you have paid for but not yet received. This applies whether they were bought as part of a program or on their own.

- Lessons and mock interviews already delivered are not refundable.
- The Interview Question Bank is a digital resource and is not refundable once access has been granted. It is excluded from the calculation below, and refunding the rest of a program does not end your access to it.
- If you have paid the program balance and then withdraw, we refund the value of the lessons and the mock interview not yet delivered, worked out using the apportionment in Schedule A.
- Approved refunds are returned to your original payment method within 7 business days.

Nothing in this section limits any right or remedy you have under the Australian Consumer Law that cannot lawfully be excluded.

6. Interview Question Bank access period

If you are applying in the 2027 admissions round, your access runs until 31 December 2026.

If you have an interview scheduled in early 2027, send us evidence of it, such as your interview invitation or confirmation email, and we will extend your access to the end of your interview date.

7. Intellectual property and use of our materials

Everything we provide stays ours. This includes the Interview Question Bank, lesson slides, feedback reports, marking guides, sample responses, mock interview materials, and anything else we give you during the program.

You may use these materials for the enrolled student's own interview preparation. You may not:

- share, forward, distribute, sell or publish any Question Bank question, station, marking guide or sample response to anyone who is not a current Voyager Academy student;
- download, screenshot, photograph, transcribe, copy or otherwise reproduce the Question Bank or its contents;
- record any lesson or mock interview, or reproduce our lesson slides or feedback reports, other than for the student's own study;
- give anyone else your Question Bank login, or let anyone else use your access, including a sibling, parent or other family member.

If you break this clause we may suspend or end your Question Bank access and your enrolment, without refunding the Question Bank component of your fee, and we keep any other rights the law gives us. We may also charge you the cost of replacing material we have to withdraw and rebuild as a result.

8. Recordings

We record mock interviews so that you can review your performance. The recording is provided to you and is covered by clause 7. We do not publish it or share it outside Voyager Academy without your written consent.

If you would prefer not to be recorded, tell us before the mock and we will run it without a recording.

9. Your responsibilities

Please join each lesson on time, with a working camera, microphone and internet connection, and with any preparation we have asked for.

We expect courteous conduct from students and parents, and our tutors will treat you the same way. We may end this agreement if anyone behaves abusively or inappropriately, in which case clause 5 applies to anything not yet delivered.

10. No guarantee of results

Interview results depend on many things, including the work the student puts in and decisions made by each university. We cannot and do not guarantee any interview outcome, offer or place. Our fees are for the preparation itself, not for a result.

11. Liability

To the extent the law allows, we are not liable for indirect or consequential loss arising from our services, and our total liability for any claim is limited to the amount you have paid us for the sessions the claim relates to.

Nothing in this agreement excludes any guarantee, right or remedy under the Australian Consumer Law that cannot lawfully be excluded.

12. Privacy

We handle personal information in line with our privacy policy, which forms part of this agreement.

13. General

Notices under this agreement are given by email, to voyagereducation.au@gmail.com for us and to the email address you give in the acceptance block for you.

This document and our terms and conditions are the whole agreement between us about the interview programs, and replace anything discussed beforehand. The version of this agreement that applies to your enrolment is the one you signed, unless we both agree to a change in writing.

If any part of this agreement is found to be unenforceable, the rest of it continues to apply.

This agreement is governed by the laws of New South Wales, Australia, and the courts of New South Wales have jurisdiction over any dispute.

Schedule A. How a program fee is apportioned for refunds

Each program fee is made up of the components below. We use these figures to work out a refund under clause 5.

Interview Question Bank (not refundable once access is granted)	\$175.50
5 lessons at \$49.50 each	\$247.50
1 mock interview with written report	\$202.50
Total	\$625.50

Worked example: a 1-on-1 student pays the full \$805.50, completes three lessons, then withdraws before the mock. Two lessons (\$171) and the mock (\$202.50) have not been delivered, so the refund is \$373.50.
